**SCHOLARSHIP ESTABLISHMENT CRITERIA AND
MANAGEMENT**

1. THE SCHOLARSHIP COMMITTEE HAS THE DISCRETION TO AWARD ONE SCHOLARSHIP OR MORE THAN ONE, ASSUMING MONEY IS IN THE FUND.
2. THE AWARDED SCHOLARSHIP FOR ANY SELECTED APPLICANT WILL BE \$100.00.
3. IF THERE IS NO QUALIFIED CANDIDATE, THE SCHOLARSHIP MONEY MAY BE CARRIED OVER TO THE SUCCEEDING YEAR(S).
4. THE MONEY FOR THE SCHOLARSHIP WILL BE THE INTEREST GENERATED FROM A PERPETUAL INVESTMENT TO BE MANAGED BY THE HELMVILLE COMMUNITY CLUB TREASURER.
5. ANY INTEREST OVER \$100.00 WILL BE ACCRUED IN THE PERPETUAL INVESTMENT UNTIL A SECOND \$100.00 CAN BE GENERATED.
6. ANY DONATIONS TO THE MEMORIAL SCHOLARSHIP FUND SHOULD GO INTO THE INVESTMENT FUND AND REMAIN, GENERATING INTEREST MONEY FOR ADDITIONAL SCHOLARSHIPS.
7. AFTER TEN YEARS FROM ESTABLISHMENT OF THE HELMVILLE MEMORIAL SCHOLARSHIP, THESE REQUIREMENTS WILL BE REVIEWED BY THE BOARD OF DIRECTORS AND RECOMMENDED CHANGES MADE AS THE DIRECTED BY THE THOSE ON THE BOARD OF DIRECTORS.
8. IF THERE IS EVER NO LONGER A NEED FOR THIS SCHOLARSHIP FUND, THE MONIES SHALL REVERT TO THE HELMVILLE COMMUNITY CLUB OR WHEREEVER DIRECTED BY THE HELMVILLE COMMUNITY CLUB BOARD OF DIRECTORS.
